WHEREAS, under Ordinance No. 8, series of 2009, of the Sangguniang Bayan of the Municipality of Pilar, Bataan, the rental fees on Pilar Convention Center for social gathering, symposium and other purposes was fixed under Section 3, on the following rentals:

And any amendment and/or modification made hereto shall be considered as an **ADDENDUM** and integral part of this Ordinance, particularly in the provision of the **REVISED REVENUE CODE** of 2012.
