RESOLUTION NO. 100, S. 2014

A RESOLUTION ADOPTING AND IMPLEMENTING PROVINCIAL ORDINANCE NO.01, SERIES 2013, THE COMPREHENSIVE ANTI-TOBACCO SMOKING CONTROL PROGRAM ORDINANCE FOR THE PROVINCE OF BATAAN.

WHEREAS, under Ordinance No. 8, dated August 7, 2008 of the Sangguniang Bayan of the Municipality of Pilar, Province of Bataan, entitled: **AN ORDINANCE PROHIBITING AND BANNING SMOKING IN ALL PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF PILAR** were enacted and approved with the belief and spirit that smoking can be totally eradicated particularly among the student and the youth;

WHEREAS, the Philippine Clean Air Act of 1999, otherwise known as R.A. 8749, declares the right of every citizen to breath fresh and clean air; thereby prohibiting smoking inside enclosed public places including public vehicles and other transport, and directs Local Government Units to implement this provision of the law;

WHEREAS, this Body recognizing that local government must act with urgency to denormalize the culture of smoking and tobacco consumption among the youth and even with our adults, not only to avoid and protect them from devastating health diseases and environmental consequences; this Body;

UPON MOTION on Hon. Antonio G. Pimpinio and duly seconded by the Majority Members of the Sangguniang Bayan, be it;

RESOLVED, as it is hereby resolved, that this Body in session and assembled hereby adopts and implemented with full force and effort **THE SMOKE FREE ORDINANCE OF THE PROVINCE OF BATAAN** not only to show the support to the programs and development plans of our beloved Governor, Hon. Albert S. Garcia, but likewise to totally eliminate the social menace of our society, the culture of smoking among men and women, including the majority of the student populace to gain 100% smoke-free environments, and to safeguard most of all, their lives in the causes of tobacco related diseases.

RESOLVED FURTHER, that scientific and legal aspect in providing ventilation and air filtration, including the use of designated smoking areas, as provided in Ordinance No. 8, dated August 7, 2008 of the Sangguniang Bayan of the Municipality of Pilar, have repeatedly been shown to be ineffective, thus it is the majority opinion of the Members of the Sangguniang Panlalawigan be used and implemented by the Local Chief Executive, Mayor Alicia D. Pizarro, in performance of her mandated tasks, and that Municipal Ordinance No. 8, dated August 7, 2008 of the municipality remains in full force as per record and image of personality.

RESOLVED FURTHERMORE, that copies of this resolution be furnished all the Sangguniang Bayan of the eleven (11) municipalities to ensure the adoption of 100% Smoke-Free Ordinance among their constituents.

RESOLVED FINALLY, that copies of this resolution also furnished Honorable Albert S. Garcia, Province of Bataan, Honorable Efren Pascual, Jr., Vice Governor, representing the Sangguniang Panlalawigan and Mayor Alicia D. Pizarro, for their information and ready reference.
