RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, MAYOR ALICIA D. PIZARRO, TO REPRESENT THE MUNICIPAL GOVERNMENT OF PILAR, BATAAN TO ENTER INTO Α MEMORANDUM OF AGREEMENT WITH THE BUREAU OF FISHERIES AND AOUATIC RESOURCES (BFAR) REGION III FOR THE **IMPLEMENTATION** OF **SUPPLEMENTARY SUPPORT** FOR LIVELIHOOD TO FISHERFOLK PROGRAM IN THIS MUNICIPALITY.

WHEREAS, the Local Chief Executive with the Sangguniang Bayan of Pilar, Bataan is concerned with the Welfare of its constituents particularly self-employment opportunities and in intensifying efforts in reducing poverty;

WHEREAS, the Bureau of Fisheries and Aquatic Resources (BFAR) provide support to the fishery primarily to the Municipal Fisher Folks to alleviate poverty and the provision of Supplementary Livelihood among them through appropriate technology, research, production and other services;

WHEREAS, the BFAR Region III, allocate three (3) units Marine Engines to Fisher Folks in the Municipality of Pilar, Batan as supplementary support for their Livelihood, including the provision of technical assistance on the overall operation and management of the said units;

WHEREAS, the proposed fisher folk association beneficiaries of the Supplementary Support for Livelihood Program in the Local Government Unit of Pilar are as follows:

- a) Samahang Mandaragat ng Balut II, Pilar, Bataan
- b) Nagkakaisang Mangingisda ng Wawa, Pilar, Bataan
- c) Samahan ng Mangingisda sa Sitio Maasim, Pilar, Bataan
