RESOLUTION NO. 103, S. 2014

A RESOLUTION REQUESTING THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR), REGION 3 TO DONATE TO THE MUNICIPALITY OF PILAR, PROVINCE OF BATAAN THE MOTORIZED BANCA KNOWN AS "KING JONATHAN I" FORFEITED BYTHE GOVERNMENT UNDER CRIMINAL CASE NO. 13101 ISSUED BY THE REGIONAL TRIAL COURT OF BATAAN, BRANCH I.

WHEREAS, the present administration spearheaded by Honorable Mayor Alicia D. Pizarro and the Sangguniang Bayan, is looking for all avenues wherein they can resolved the growing clamor from the fisher folks regarding the problem of dynamite and illegal fishing as to how it could be controlled, if not totally eradicated;

WHEREAS, one solution proposed from the Bantay Dagat, is to buy a patrol boat which could be used in patrolling the municipal waters, particularly on night time wherein the operation of "galadgad" are being rampant, including "sea pirates" whom from time to time operates in the territorial waters of Pilar to victimized small fishermen of their motorized banca's and fishing paraphernalia;

WHEREAS, the Municipality of Pilar, being a third class municipality cannot afford to such exorbitant measures, leaving no other recourse but to wade another way wherein they can resolved the besetting problem on fisher folks;

WHEREAS, in consonance to these accounts, some reliable sources reach this Body that sometimes on June 4, 2014, the Regional Trial Court of Bataan, Branch I, have released an Order for the forfeiture of a certain motorized banca known as "King Jonathan I" and now under the safekeeping of the Bureau of Fisheries and Aquatic Resources (BFAR), which to the knowledge of Mayor Alicia D. Pizarro, could be converted into a Patrol Boat with minimal expenses;

RESOLVED, as it is resolved, that this Body duly assembled and in session to **SUPPORT** by means of this resolution, the request of Mayor Alicia D. Pizarro, to Honorable Wilfredo M. Cruz, OIC Regional Director, Bureau of Fisheries and Aquatic Resources, Region 3, City of San Fernando, Pampanga to donate to the Municipality of Pilar, Province of Bataan the forfeited motorized banca known as "King Jonathan I", so that we could protect the aquatic and marine resources of our municipality to unscrupulous "sea pirates" and fishermen who uses illegal fishing method.

RESOLVED FURTHER, that copies of this resolution be furnished Hon. Wilfredo M. Cruz, OIC Regional Director, Bureau of Fisheries and Aquatic Resources, Region 3, City of San Fernando, Pampanga, for his favorable consideration and appropriate action; and Mayor Alicia D. Pizarro, this municipality and other concerned parties for their information and ready reference.
