RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, MAYOR ALICIA D. PIZARRO, TO SIGN AND ENTER INTO CONTRACT IN BEHALF OF THE MUNICIPAL GOVERNMENT OF PILAR, BATAAN WITH THE HEREIN LISTED WINNING BIDDER FOR THE IMPLEMENTATION OF TWO (2) INFRASTRUCTURE PROJECTS CHARGED UNDER THE 20% DEVELOPMENT FUND OF THIS MUNICIPALITY.

WHEREAS, relative to the provision of RA 7160, the Local Chief Executive is authorizing by law to enter into a Contract in behalf of the Local Government Unit concerned as authorized by the Local Sanggunian;

WHEREAS submitted before this August Body is the request of the Local Chief Executive, Mayor Alicia D. Pizarro to authorize her to sign and enter into Contract with respect to the following projects;

WHEREAS, the revised guidelines and documentary requirements for common government transaction as prescribed in COA Circular No. 2012-001, dated June 14, 2012, provides that one of the basic requirements, needed for all types of procurement through public bidding particularly infrastructure projects is an authorization by the local Sanggunian for the Local Chief Executive to enter into such transaction or contract;

WHEREAS, finding merit on said request as evidence by bid documents, this August Body, deems it in order to pass this resolution in order to enter payment of the above-cited two (2) projects;

NOW THEREFORE, on motion of SB Member Gerry S. Sanchez, duly seconded by the Majority Members of the Sanggunian, be it;

RESOLVED, as it is hereby resolved by this Body duly convened and assembled, to authorize the Local Chief Executive, Mayor Alicia D. Pizarro to sign and enter into Contract in behalf of the Municipal Government of Pilar, Bataan with the winning bidders above-mentioned for the implementation of two (2) infrastructure projects as herein stipulated charged under the 20% Development Fund of this Municipality.
