### RESOLUTION NO. 93, S. 2014

#### **RESOLUTION CREATING AND APPROVING GUIDELINES FOR THE UTILIZATION OF PACKAGES RECEIVED FROM THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH) OF PILAR RURAL HEALTH UNIT (RHU), PILAR, BATAAN.**

**WHEREAS**, Pilar Rural Health Unit (RHU) and Lying-in-Clinic is a PHILHEALTH Accredited Facility providing Tuberculosis Directly Observed Therapy Short Course (TB DOTS), Maternal Care Package (MCP), Primary Care Package (PCP) and Malaria Treatment Package (MTP);

**WHEREAS**, Pilar RHU and Lying-in-Clinic is entitled to **PHILHEALTH** reimbursement that will be spent on operating expenses of the facility as well as improvement of its services, and on professional fees for the facility's health personnel;

**WHEREAS**, this Sanggunian is authorize to create and approve guidelines for the utilization of packages received from **Philhealth** based on the existing policies and guidelines prescribed by the Department of Health (DOH);

**NOW THEREFORE**, on motion of SB Member Edgardo Z. Lulu and duly seconded by the Majority Members of the Sanggunian, be it;

**RESOLVED**, as it is hereby resolved, that this Body duly convened and assembled, to create and approve the following guidelines for the utilization of packages received from **PHILHEALTH** of Pilar Rural Health Unit (RHU), Pilar, Bataan:

### **1. TB DOTS Package**

- 40%** for facility fee (operational cost for medicines, medical supplies, equipment and information technology (specific for the facility use needed to facilitate reporting and database build-up), capacity building, infrastructure or any other used related necessary for the delivery of the required services)
- 25%** for the referring physician or additional facility fee if there is no referring Physician.
- 35%** for the services of the staff of the TB DOTS facility which include;
  - 20% for the Physician
  - 15% for the Public Health Nurse
  - 15% for the Municipal NTP coordinator
  - 15% for Medical Technologist
  - 20% for Midwives
  - 15% for Barangay Health Worker/Treatment Partner

### **2. Maternal Care Package**

- 60% for the facility fee
- 40% for the services of the staff of the Lying-in-Clinic facility

### **3. Primary Care Package.**

80% for the operational cost and shall cover;

- Minimum of 40% for drugs, and medicines under the Philippine National Drug Formulary (to be dispensed at the facility) including drugs and medicines for Asthma and pneumonia.
- Maximum of 40% for reagents, medical, supplies, equipment (i.e. ambulance ambubag, stretcher, etc) information technology (IT equipment specific for facility use needed to facilitate reporting and database build-up), capacity building for staff, infrastructure or any other use related, necessary for the delivery of required service including referral fees for diagnostic services if not able in the facility.

20% shall be exclusively utilized as honoraria of the staff of the health facility and in the improvement of their capabilities to be able to provide better health services.

- 10% for the Physician
- 5% for other Health Professional Staff of the facility
- 5% for Non-Health Professional/Staff, including Volunteers

### **4. Malaria Treatment Package**

- 80% for the delivery of the required service; e.g. drugs, supplies, equipment
- 20% administrative cost that shall be divided among the Health Personnel of the Rural Health Unit/Health Centers including the Barangay Health Workers.

**RESOLVED FURTHER**, that there will be a creation of a separate Special Trust Fund for this purpose.

**RESOLVED FINALLY**, that copy of this resolution be sent to all parties concerned for their ready reference and appropriate action.
