RESOLUTION NO. 95, S. 2014

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. ALICIA D. PIZARRO TO REPRESENT Lt. JUAN J. ALDABA MEMORIAL HEALTH CENTER – PILAR RHU, PILAR, BATAAN TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH ST. MICHAEL'S HOSPITAL, ORION, BATAAN, REPRESENTED BY MEDICAL DIRECTOR, DR. ANGELITO N. BALUYOT, JR., PERTAINING TO PHILIPPINE HEALTH INSURANCE SYSTEM ACCREDITATION.

WHEREAS, Section 17 of RA 7160, provides that every local government unit shall exercise such powers and discharge other functions and responsibilities, as are necessary to efficient and effective provision of the basic services and facilities;

WHEREAS, such basic services and facilities include, but are not limited to health services which include the implementation of programs and projects or primary health care, maternal and child care, communicable and non-communicable disease control services, access to secondary and tertiary health services needed to carry out the service herein enumerated.

WHEREAS, under Philhealth Circular No. 010 s. 2012, the Philippine Health Insurance Corporation aims to ensure that all Filipinos have access to quality health services that are efficiently delivered, equitably distributed, fairly financed and appropriately utilized by an informed and empowered public;

WHEREAS, the services offered by St. Michael's Hospital at Orion, Bataan which referred to as the "Referral Facility" in which our constituents will be benefited are the following:

- a) **CHEST XRAY**: Radiologic examination of the chest viewed as posteroanterior (PA view) or anteroposterior (AP view) and L (lateral View).

- b) **LIPID PROFILE:** Fasting lipoprotein profile including major blood lipid fraction (total cholesterol, LDL cholesterol, HDL cholesterol, Triglyceride) requiring a 9-12 hours fasting.

NOW THEREFORE, on motion of SB Member Edgardo Z. Lulu and duly seconded by SB Member Fatima Elisa S. Enriquez, be it;

RESOLVED, as it is hereby resolved that this body Authorizing the local Chief Executive, Hon. Alicia D. Pizarro to Represent Lt. Juan J. Aldaba Memorial Health Center – Pilar RHU, Pilar, Bataan to enter into a Memorandum of Agreement with St. Michael’s Hospital, Orion, Bataan, represented by Medical Director, Dr. Angelito N. Baluyot, Jr., pertaining to Philippine Health Insurance System Accreditation.
